

The City Council met in a called special session on September 30, 2019 in Council Chambers. At 2:30 pm, Mayor Victoria Jackson-Stanley called the meeting to order in open session. All city commissioners were present: Commissioners Rideout, Sydnor, Foster, Cannon, and Hanson. Others present included the City Attorney, Chip MacLeod; Public Works Director, Odie Wheeler; Police Chief Mark Lewis; and City Manager Patrick Comiskey.

Commissioner Rideout made a motion to approve the agenda. The motion was seconded by Commissioner Hanson. The motion was adopted 5-0.

Public Works Director Odie Wheeler requested authorization to enter a contract with Tieder Electric, LLC. for the purchase and installation of decorative street lights for Pine Street. He also asked for the authority to negotiate the purchase and installation of additional decorative lights from the same vendor utilizing the balance of the amount awarded from the state up to \$75,000 total (includes the \$42,000 figure).

A motion to approve the request was made by commissioner foster and seconded by commissioner Cannon. The measure passed 5-0.

Mayor Jackson-Stanley read the items on the consent calendar:

Agenda Item 3, Mistletoe Market from Main Street, Cannery Way, Saturdays November 9th through December 5th, 2019;

Agenda Item 4, Festival of Wreaths, Pleasant Day is requesting to have a banner hung on Race Street from November 21st through December 5, 2019;

Agenda Item 5, STEM Event for Dorchester County, in Cannery Way, on November 2, 2019 from 10 a.m. through 3:00 p.m.; and

Agenda Item 6, ribbon Cutting/Open house at the Phillips Packing House on Dorchester Avenue, October 29, 2019 from 4:30 p.m. through 6:30 p.m., requesting a lane closure.

Commissioner Rideout made a motion to approve the consent agenda list and Commissioner Foster seconded the motion. The motion was adopted 5-0.

Old Business

Public Works Director Odie Wheeler informed the city council that the concrete for the Deep Harbor sidewalk project will cost \$2,700 more than previously presented.

Commissioner Foster made a motion for Odie to contact the person who offered to donate the materials to replace the roof of the pavilion at Cornish Park. The motion was seconded by Commissioner Sydnor. The motion passed 5-0.

Public Comment

Katie Clendaniel asked about panhandlers and religious speakers in Cannery Park. She also mentioned a house on Locust Street that has been having a yard sale on a regular basis.

Commissioner Sydnor made a motion to adjourn the meeting and Commissioner Cannon seconded the motion. The motion passed unanimously.
