

Good afternoon Sandra-

I am reaching out with a dilemma. Attached please find a request for permission to include skeet shooting in the annual Habitat for Humanity Choptank Golf Tournament being held on our property on Friday, June 10<sup>th</sup>. Per usual, we are sending in a written request however we have been asking our vendor, Pintail Point, for verification of insurance for the past few weeks. While we trust that they do have this information, we haven't been able to acquire it as of yet and do not want to find ourselves short on time to get this approval confirmed.

At this time, we were also hoping to include this activity during a May 24<sup>th</sup> event as well as June 23<sup>rd</sup>. I will send along those requests once we receive the insurance disclaimer but wanted to get this to you as soon as possible as we do not want to disappoint Habitat, in particular. They acquire a nice sponsorship for the activity and we don't want to cost them revenue. Please let me know the best way to go about securing these date options for skeet shooting here on the golf course. If advisable for me to attend a Council Meeting to better explain, I am more than happy to do so.

We appreciate your help and direction and look forward to getting this sorted out. In the meantime, should Pintail come thru with the required statement, I will forward that along as well.
